# 2024 Bear Jaw Community Cleanup

Bear Jaw, with the assistance of Coconino County Public Works, completed the collection and haul portion of the 2024 Bear Jaw Community Cleanup program as part of the NFPA Wildfire Community Preparedness Day. The intent is to remove flammable material from the home ignition zone to reduce the hazard to our citizens and first responders in the event of a catastrophic wildland fire. The dates are chosen to coincide with the time before the annual fire season when the Bear Jaw Crew is at full staffing but before they are assigned to wildfires throughout the region.

Starting on April 29<sup>th</sup>, 2024, and continuing through May 9<sup>th</sup>, 2024, 20 personnel from Bear Jaw collected bags of pine needles and slash piles to haul to Willard Springs Transfer Station. This coordinated effort included the use of 7 separate vehicles and 6 trailers. 800-man hours were put in over the duration of two-weeks with an additional 80 hours in planning. The use of GPS data allowed the acquisition of precise location and amount of material to improve the program in the future while keeping costs at an absolute minimum.

This program is designed to reduce hazard in the Wildland Urban Interface in the most difficult fuels to mitigate. Traditional costs for fuels reduction in these areas are above \$2,000 per acre and generally not available under federal and state grant opportunities. Due directly to the joint effort of our public and private partners we were able to create a safer community and reduce the risk to private property in the event of a catastrophic wildland fire in the Munds Park, Mountainaire and Kachina Village communities.

Many residents abided by the rules set out for the protection of our employees and to you, we thank you. There were those that abused the program by adding dog waste, household trash, and rocks along with exceeding the bag limit. This limits the effectiveness of the crew and puts the program at future risk. In addition to the Bear Jaw Community Cleanup program, Coconino County continues to accept green waste at Willard Springs free of charge on Fridays and Saturdays through October.

Over the two weeks, the crew collected the following from 1,192 parcels of private property.

## **Grand Totals:**

- 19,177 Individual Bags Removed
- 786 Cubic Yards of Slash Removed
- 15,000 Bags Distributed Free of Charge

Munds Park-Total Parcels collected from 862 making up 43.27%

- Cubic yards of slash- 293

Pine Del- Total Parcels collected from-20 making up 1%

- Bags collected-191= 56.74 cubic yards of pine needles
- Cubic yards of slash -7
